BUSINESS UPDATE ENTERING OF STRATEGIC COOPERATIVE FRAMEWORK AGREEMENT WITH A TELECOMMUNICATION OPERATOR

The Company will pursue the development of its novel space services and other innovative technology businesses. The Company may enter into further agreements similar to the Cooperative Agreement or other agreements in its ordinary and usual course of business. The Company is also, from time to time, in discussion with different parties including potential customers, research institutions, strategic partners, etc, to explore ways of business cooperation and collaboration.
